2022年第一季財務摘要

- 營收為新台幣72.21億元，季減11.9%/年減42.8%。營收季減主因：1)供應鏈缺料、運流瓶頸；2)季節性因素。年減則為出售泰州廠後，初期業務交接、存貨銷售所產生之高基期所致。
- 單季毛利率為29.6%，季減3.5pp/年減2.2pp。毛利率下滑，主因營收規模減少，原物料價格飆漲亦造成部份程度影響，故而抵銷產品組合調整，以及折舊費用持續降低所帶來的正面效益。
- 單季營業利潤率為15.1%，季減3.9pp/年減7.1pp，主因毛利率下滑。
- 可成大部份營收以外幣(美金及人民幣)計價，台幣貶值反映於匯兌收益22億元。
- 稅前淨利為30.45億元，季減30.8%/年減14.4%。季減主因去年第四季處分蘇州廠房墊高基期；年減則為高基期以及去年第一季供應鏈缺料尚未浮現所致。
- 稅後淨利(歸屬業主)為20.57億元，季減39.0%/年減18.1%。
- 基本EPS為NT\$ 2.81元 (4Q21 : NT\$ 4.48元；1Q21 : NT\$ 3.30元)。
- 資本支出為1.47億 (上季NT\$43mn；去年同期NT\$1.42億)。
- 折舊攤銷費用為9.31億，上季為10.24億，2021年第一季為14.19億。
- EBITDA 為20.25億，上一季為25.78億，2021年第一季為42.22億。

* EBITDA = Operating Profit + Depreciation + Amortization

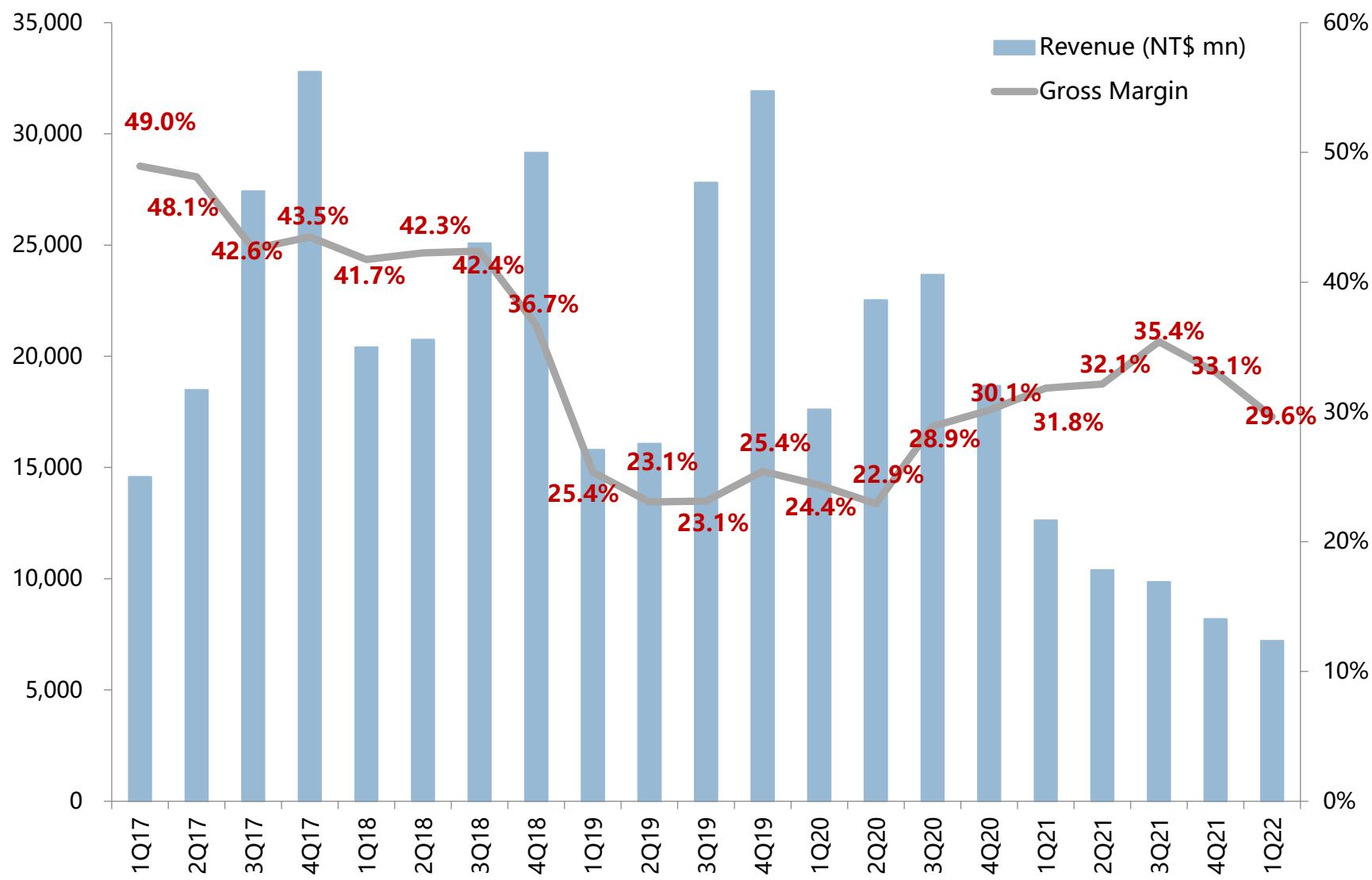

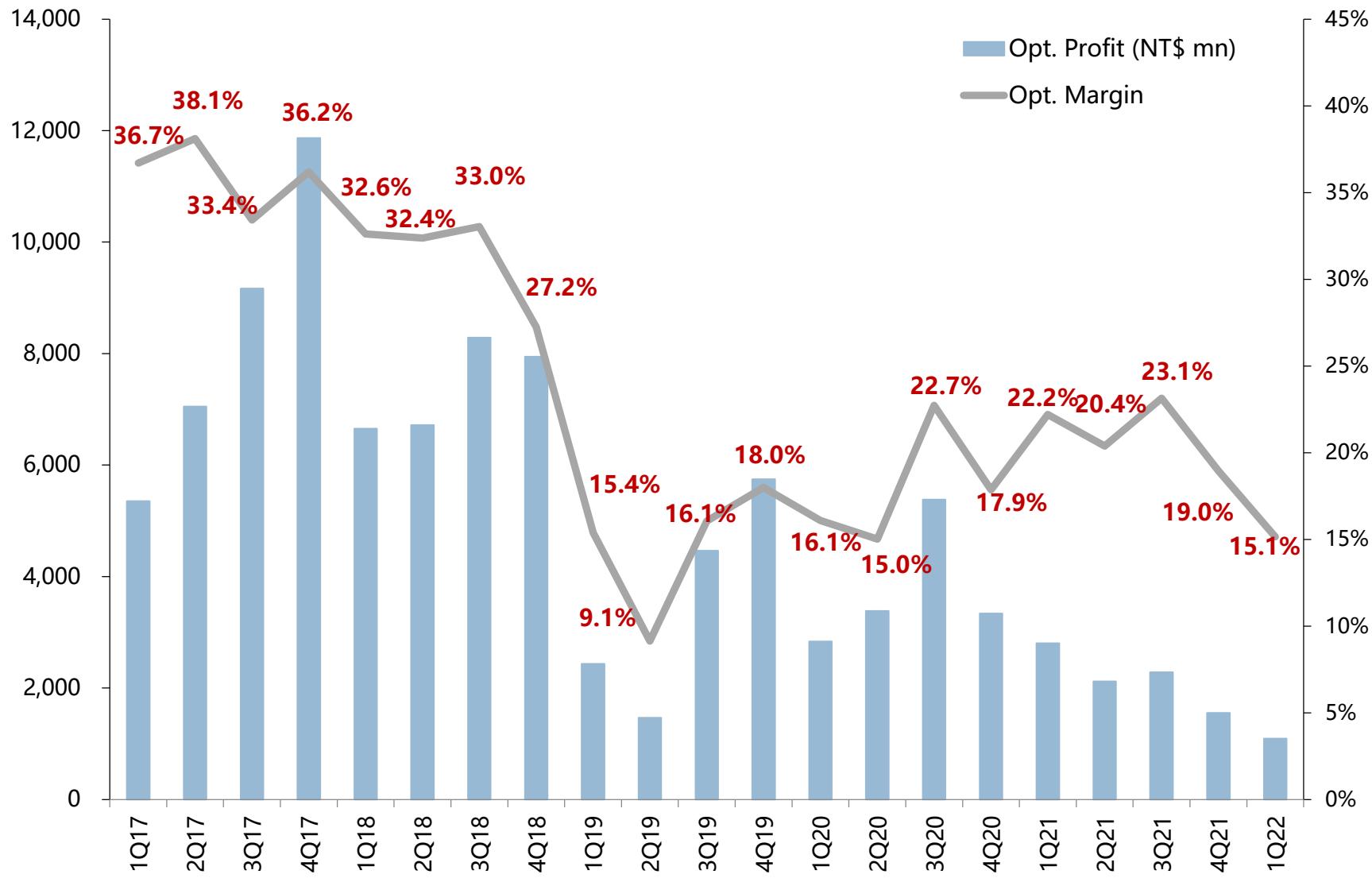

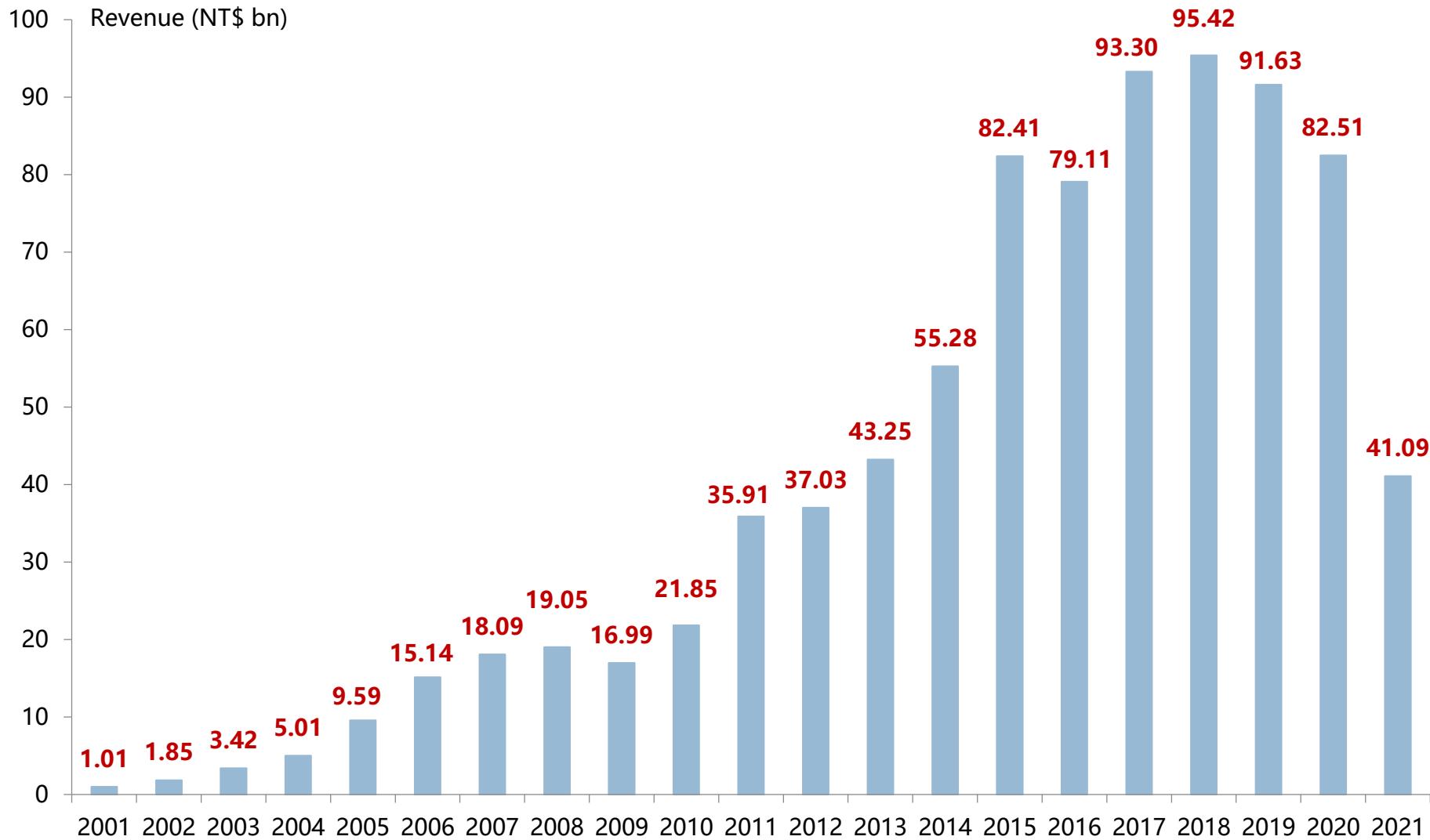

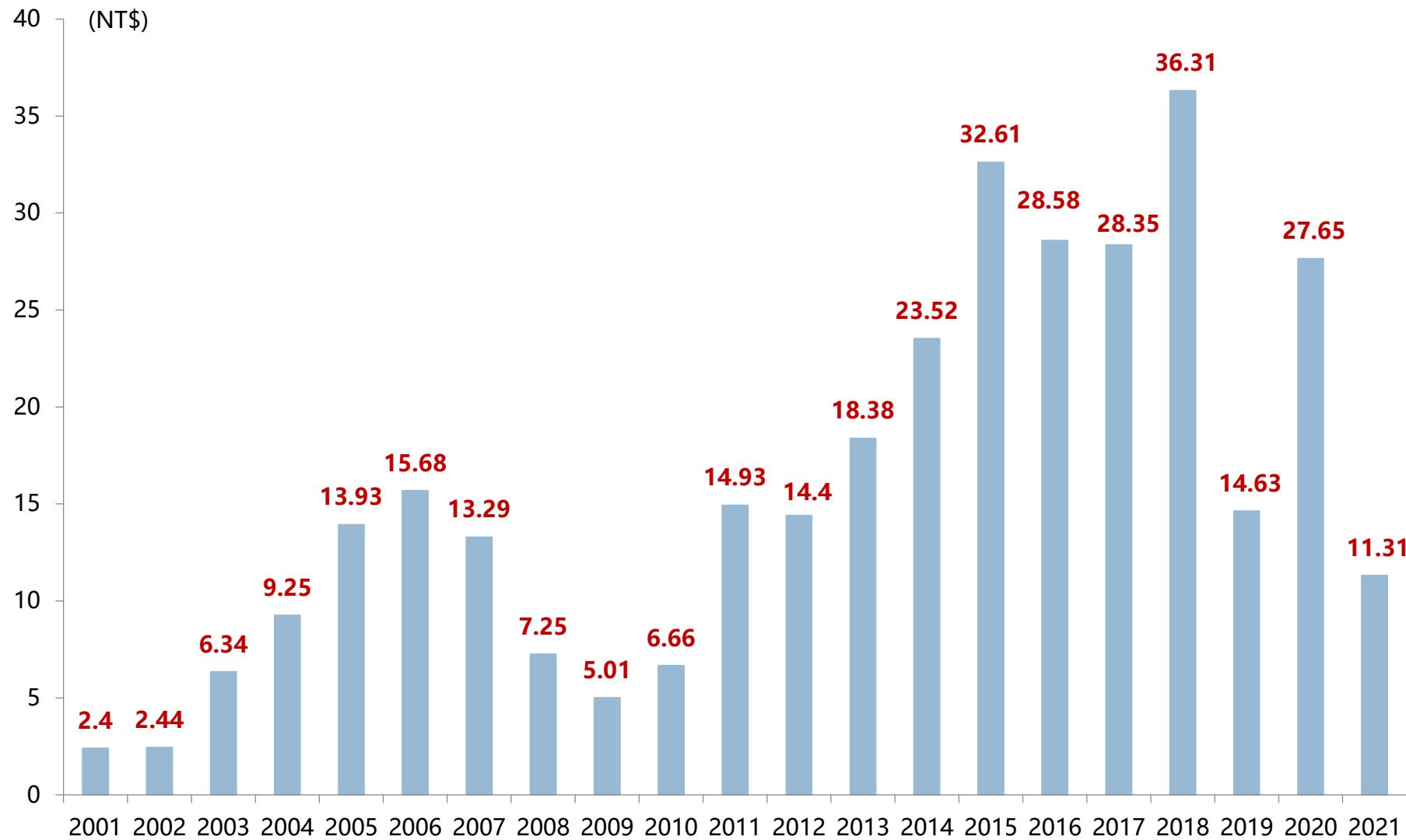


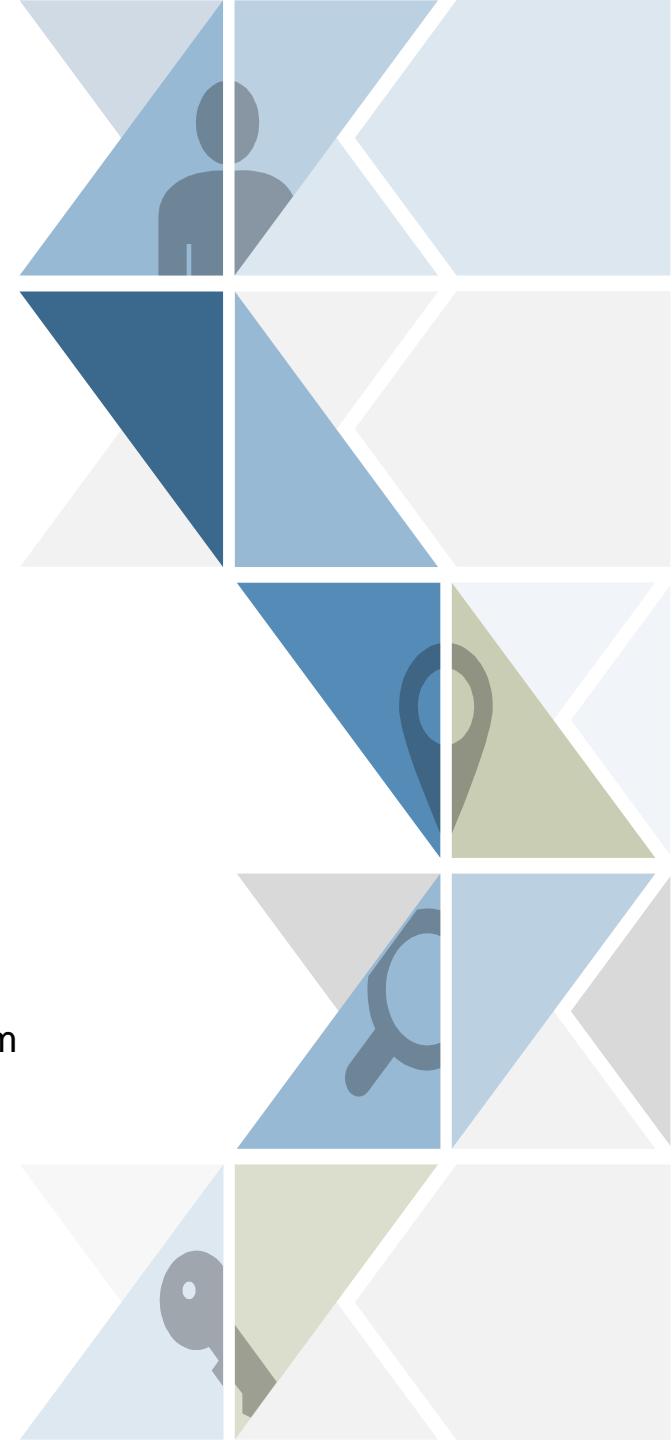
