# **1Q21 Financial Summary**

- Revenue NT\$12.6bn, -32.4% q-q and -28.3% yoy as Taizhou subsidiaries divestment was completed by end-2020 and no revenue contribution starting from year 2021.
- GM 31.8%, +1.7% q-q and +7.4% y-y mainly due to product mix.
- OPM 22.2%, +4.3% q-q and +6.1% y-y due to GM improvement and cost control.
- NPBT 3.6bn, -87.0% q-q due to one-off gains from the sale of Taizhou subsidiaries; -33.9% y-y because of revenue decline and Non-OP impact.
- NPAT (attributable to parent company) 2.5bn, -81.9% q-q/ 35.9% y-y.
- Basic EPS NT\$3.30 in 1Q21 vs NT\$ 18.16 in 4Q20/NT\$5.09 in 1Q20.
- CAPEX 142mn in 1Q21 vs 367mn in 1Q20.
- D&A 1.42bn in 1Q21 vs 0.62bn in 4Q20/2.81bn in 1Q20.
- EBITDA 4.22bn in 1Q21 vs 3.96bn in 4Q20/5.65bn in 1Q20.








