Catcher Technology reports 2012 Q1 financial results

Catcher Technology (TAIEX: 2474 TW) today reports its 2012 Q1 financial results.

The net sales of 2012 Q1 was NT\$8,656 million, down 5.4% qoq but up 22.0% yoy.

The gross margin of 2012 Q1 was NT\$3,562 million, down 15.9% qoq but up 25.5% yoy. The operating income of 2012 Q1 was NT\$2,632 million, down 23.5% qoq but up 30.4% yoy.

The net profit before tax of 2012 Q1 was NT\$3,305 million, down 11.2% qoq but up 45.9% yoy. Net profit after tax of 2011 Q1 reported NT\$2,792 million, up 3.4% qoq but up 46.1% yoy. The earnings per share of 2012 Q1 was NT\$3.72, versus NT\$3.58 of 2011 Q4.

From the percentage point of view, the gross margin of 2012 Q1 was 41.2%, down 5.1% qoq but up 1.2% yoy. The operating profit margin of 2012 Q1 was 30.4%, down 7.2% qoq but up 2.0% yoy. The net profit margin before tax of 2012 Q1 was 38.2%, down 2.5% qoq but up 6.3% yoy. The net profit margin after tax of 2012 Q1 was 32.2%, up 2.7% qoq and 5.3% yoy.
